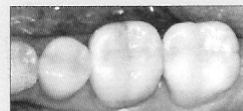

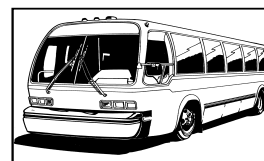

Enjoy an Amish Life experience!



Another great bus trip is being planned for Saturday, **May 12, 2007** to Holmes County to experience, first-hand, Amish living in Ohio. The Amish have maintained their core values and way of life for more than 500 years. We will hear their stories; see an actual working farm; meet the Amish people who still preserve the traditions, faith, values and work ethics handed down from their forefathers; and be a part of **“The Amish Experience”**.

Departs from the Summit Masonic Complex at 8:30 a.m. on Saturday, May 12, 2007.

- 9:15 a.m. - Our first stop is at Warther’s Museum, where we will tour the family museum and experience what the Smithsonian calls “priceless works of art” carved in ivory and exotic woods, created by “World Master Carver,” Ernest “Mooney” Warther. You can also stroll through the Swiss flower gardens, tour the kitchen knife factory, and admire the family’s button and arrowhead collections.
- 11:45 a.m. -Enjoy delicious soup, salad bar, beverage and choice of pie at a local restaurant.
- 1:00 p.m. - Our group will visit the Amish and Mennonite Heritage Center, “Behalt,” to watch a movie about the Amish. We will then experience the narrated 10’ x 265’ cycloramic mural illustrating the living history of Amish and Mennonites, beginning in Zurich, Switzerland, from 1525 until the present.
- 2:15 p.m. - Schrock’s Amish Farm and Village to explore an Amish home, the barn area, where you may see horseshoeing, cow milking and field work being done. Take a horse-drawn wagon ride. The kids can ride the train that traverses the farm or they may feed the farm animals. You will also have some time for shopping at nearby stores. Visit Grandma Fannie’s Quilt Barn, The Berlin Antique Mall, The Berlin Craft Mall, Berlin Leather and Pets, as well as other local Amish-business stores.
- 4:30 p.m. - We get back on the bus for a back-roads tour with our step-on guide.
- 5:15 p.m. - Walnut Creek Cheese Store to purchase cheeses, smoked meats, chocolates, bulk foods, kitchen miscellanea, Amish baked goods, deli food, a huge selection of teas, jams and jellies, super-sized ice cream cones and so much more. Feel free to bring a cooler to accommodate your purchases.
- 6:15 p.m. - Experience a traditional Amish wedding feast, including chicken and meatloaf along with all the trimmings. Our group will hear from Jo Ann Hershberger and her father John Schrock, as they tell their stories of growing up as Amish children. One lucky couple will be chosen as the bride and groom for the evening. You can be part of this cultural trip and learn about this religious community in Ohio.

Our Amish tour will end at Summit Masonic Complex at approximately 9:00 p.m.
